

UNDERGRADUATE INTERNATIONAL STUDENT-TO-STUDENT GRANT APPLICATION

The International Student-to-Student Grant Fund is made up of fees collected from undergraduate international students and is used to help pay the education-related expenses of those undergraduate students who demonstrate financial need. Awards will range from \$100 to \$300; the number and size of awards will vary with the availability of funds. A special committee will determine the award recipients.

To be eligible, a student must have completed at least one semester at SIUC, must have paid the STS fee for the current semester*, must have a GPA of at least 2.0, **must be an undergraduate, and <u>must be registered for</u> <u>at least 12 hours</u> during the each semester or <u>for 6 hours</u> during the summer semester. Spouses and children of SIUC Graduate Assistants are eligible for this award, as long as they pay the STS fee.

Applications should be returned to Center for International Education CIE, 425 Clocktower Drive, Woody Hall, by the first two weeks of the semester. Awards will be announced by the 5th or 6th week of classes each semester.

If you have **not requested a refund of the STS fee, you have paid this fee. It is included in the total fees charged to students.
